



Pricers

Estimators

Estimators use ProPricer EE to begin the proposal data process by inputting or importing Tasks, Resources, and Materials by SOW, CLIN, or WBS. As a single point of entry for 1 to 1,000 users, teams from separate business divisions can come together to work on a single proposal. Additionally, sub-contractor bidder data can be electronically imported into the prime proposal via spreadsheet or ProPricer format, eliminating additional data entry, and adding another level of accuracy to the overall process. Generate analysis reports, bid cost summary reports, and import or export data to and from third party applications such as Parametric tools, BOE tools, and Risk tools based on your company's proposal generation process.
